# Committee Reports

## Alberta Construction Safety Association

Board Of Director's Meeting (June 21, 2007)

### Strategic Planning Session

Strategic Planning Session was held May 24 and 25, 2007. The following lists the action plans developed to address key strategic issues:

#### Manpower shortages – staff and volunteers

- Be proactive in looking for replacement staff for leaves of absence.
- Develop and use a referral program to enhance recruitment of staff, advisors.
- Create a “Human Resources Department”.
- Have more owner representatives on the ACSA Board.
- Have more worker representative on the Regional Safety Committees.

#### Government Driving ACSA Direction

- The ACSA should meet regularly on at least an annual basis with the Minister, Deputy Minister and ADM's to express concerns.
- Encourage ACSA member associations to identify key safety issues within their industries to relevant Ministers, DM's and ADM's when they meet with them.

#### Edmonton space/capacity

- As the demand for safety training increases so will the need for increased space in the Edmonton area.
- Option for increasing space in the Edmonton area could include a new location in a couple of years.

#### Health and Safety Association Network issues

- Utilize the Health and Safety Association Network (HSAN) to set standards for health and safety training on a provincial level that will be recognized in a provincial capacity.
- Utilize the Canadian Federation of Construction Safety Associations to establish inter-provincial equivalencies for health and safety training.
- Work with the HSAN to develop the HSAN Safety Training Tracking System to encompass all types of health and safety training.

#### Nurturing partnership with Association and Trade Associations

- Provide more access to information about industry and trade associations, including possibly having more links to the associations on the ACSA website.
- Develop partnerships with associations and companies.

#### Expansion of E-Learning

- Research and access funding for alternate language delivery of e-learning programs.
- Develop/resource on-line reference library.
- Review all current classroom courses for theory portions that can be delivered electronically.

### New Building - Calgary Update/Edmonton Update

The building in Calgary is progressing with most of the structural steel in place.

Within the next three years, the ACSA will have to consider expanding their Edmonton building or moving to another location.

### Health and Safety Association Network Update

The group is working on a process for accredited training. A two day meeting was held on June 18 and 19 to discuss the development needs of the industry safety training database. This system would be available to all employers and there could be the possibility for a database that small employers could download to assist them in tracking safety training.

### Certifying Partner Update

Disabling injury rate and the lost time rate will be used to identify poor performers.

They are researching methods to highlight traffic safety in all industries.

They are working on systems to address companies falsifying COR.

### Canadian Traffic Education Course

The ACSA is looking at identifying the needs of the construction industry as it relates to traffic safety education and the partnering within the right groups to meet the needs of the industry.

### Construction Sector Council Supervisory Training Program

The Construction Sector Council is looking at a “Construction Supervisor”. This is following the same line as the provincial committee that is looking at the “Industrial Construction Crew Supervisor Occupation”. The LSE program has been accepted as the safety component.

### Construction Sector Council, CSTS

The CSC is still interested in working with the ACSA to develop a system where CSC could use CSTS as an orientation system to the construction industry. The ACSA will look at how they can work with the CSC after the CSTS enhancement has been completed.

### OH&S Code Change Process

The ACSA is still working with Workplace Health and Safety to ensure we have right people reviewing the specific areas of the code.

## Electrical Technical Council

Clem Gratton, PEC

The Safety Codes Council annual meetings were held in Jasper this year on May 4th and May 5th. This year for the first time the AEICTC (Alberta Electrical Industry Codes and Technical Conference) May 2nd and 3rd were held in conjunction with the SCC meetings. I think this proved to be a very good format as all the meetings were very well attended.

The AEICTC meetings with their new format went very well with good participation and many issues being brought forward. As most of you are well aware with the adoption of the new code last fall there is still much controversy and debate on several issues such as the fluorescent fixture disconnects, and the secondary seals. It appears that the manufacturers are steadily developing products to satisfy these rule changes. Some clarifications on some of the new rules to help industry deal with them across the province uniformly were also debated such as 20amp t-slot receptacles in kitchens, and Kitchen Islands and what constitutes an Island. Quite a bit of discussion arose around the temporary construction receptacles and if receptacles which are installed inside a home under construction should fall under that category. The new Draft Alberta Electrical Utility Code was reviewed and to this date has still not been adopted as I believe legislation is bogged down in other priorities, as is the case with the new Permit Regulation. The next AEICTC will be held in conjunction with the SCC meetings again next May 2008 in Banff.

The Electrical Technical Council also took the opportunity to hold meetings since most of the committee members were also attending the SCC and AEICTC meetings. It was held on May 3rd and dealt with a few of the items that were forwarded from the AEICTC meetings but also approved the new course material for the Group A CEC Course and struck a task force to prepare documentation to send to CSA advising of our industry's concern with going to a 3 year code cycle and our opposition to it.

The next Electrical Technical Council meeting will be held September 27th, 2007 in Edmonton.

The next CEC Code Committee meeting will be held on July 19th, 2007 also in Edmonton.

## Master's Update

I'm pleased to report that at the recent Annual General Meeting the Electrical Contractors Association of Alberta voted unanimously to amend our bylaws to incorporate the new Certified and Registered Master Electrician titles, in addition to other changes to provide for Board representation, and Master Advisory Sub-Committee. This is one of three substantial changes necessary in industry to realize our vision.



With respect to the second, a meeting was held with officials from the Ministry responsible for POARA, and the best information we have is that it is possible that a draft regulation will be in our

hands from Legislative Services this fall. There is some suggestion that a stakeholder review be considered in advance.

As for the third, Municipal Affairs has informed us that they are trying to push the new Permit Regulation through. Included in that package is the amendments to the Certification and Permit Regulation which removes all permit requirements from it and extends its expiry date. As soon as the PEC Regulation is amended, the Permit Regulation will be amended to refer to certified and registered master electricians and reference to master electricians removed.

Special thanks to Pierre McDonald for making the effort to attend ECAA's AGM. It was great to see him there!
