GILHOOLY, Ronald Burns October 2, 1923 - July 22, 2015

(ECAA Past Provincial President) It is with great sadness but peaceful hearts that we announce the passing of Ron Gilhooly. Alberta Infrastructure Tender Procedure Changes Please see below an important message from Alberta Infrastructure: As part of Alberta Infrastructure's procurement modernization work, the following change to reduce non-value added activities in the procurement process is being proposed:

- In the current process, tender addenda, award notifications, and other communications are sent by Alberta Infrastructure to Contractors via fax and courier.
 - In the proposed revised process, Alberta Infrastructure will use email whenever possible. Couriers and faxes will be used as necessary in the short term, with the goal of eventually eliminating fax transmissions altogether.
- *Please note that this change does not affect bid amendments that are sent by Contractors to Alberta Infrastructure via fax. ACA Seeks Member's Comments on Barrier Free Sites

The Barrier Free Council (representing persons with mobility or vision limitations) is proposing some changes to ensure barrier free access for pedestrians near building sites. Attached below is a document prepared by Barrier-Free Sub-Council, for consideration by Building Technical Council and Fire Technical Council, with intention to provide guidance to safety codes officers, industry and owners and to promote consistency of approach to temporary provisions for site safety in the vicinity of construction sites.

OHS Advisory: Worker Exposure to Asbestos

Alberta Occupational Health and Safety have issued an advisory on what to do if you encounter asbestos on the job site. During building demolition, asbestos fibres may be released if building materials containing asbestos have not been removed. If the building was built before 1990 there is a chance that some materials may contain asbestos.

Arc Flash & Shock Electrical Safety Training based on CSA Z462-2015 Developed for workers that perform energized electrical work. The course curriculum is based on the 3rd edition of CSA Z462, published in 2015. The overall course content was developed using industry accepted best practice standards as the underpinning in support of meeting Provincial or Federal regulatory due diligence for arc flash and shock.

ESTS Electrical Worker training is focused on the practical application of CSA Z462 within the workplace and providing documentation tools in support of the Employer's overall Occupational Health & Safety Management System and an Electrical Safety Program. Employers are required to have an updated Electrical

Safety Program that incorporates the new requirements from CSA Z462-2015 for workers to receive the most benefit from this course.

The ESTS Electrical Worker course is broken down into five sections for ease of use. Workers should self-pace themselves based on their understanding of the subject matter. All workers are encouraged to stop and start their course by saving their progress before exiting.
