ECAA participated in **Careers the Next Generation Career Expo** October 1st in Fort McMurray held at the Syncrude Sports & Wellness Center at Keyano College. Thank you to Crystal Barter with DC Wiring for volunteering.

Recent City of Edmonton notices in regards to switches requiring bonding conductors connected to device boxes. The ECAA working hard on our members behalf has had conversations and discussions in regards to this issue. City of Edmonton electrical inspectors were noting observations on inspection reports, that they would in the near future be calling for bonding conductors to be installed from device boxes, to the switches that have grounding screws on them, similar to grounding screws on receptacles. After a request for clarification by the ECAA, the City of Edmonton chief electrical inspector, Mr. Gerry Wiles, after consultation with the Provincial chief electrical inspector, Mr. Clarence Cormier, has issued a memo to his Electrical Inspectors. It read that this bonding conductor from box to switches with ground screws would not be required.

ECAA is gathering concerns and questions around the new electrical, building and fire codes which will be organized and presented to the inspectors through the Chief Electrical Inspector for clarification and utility in enforcement & expectation throughout the province. This should facilitate better communication between all inspectors provincially so that code rules are interpreted the same way in each jurisdiction. Minimum wage in Alberta has fallen behind the earnings of Albertans in general. Gradually increasing minimum wage will help reduce staff turnover, improve fairness and help low-income Albertans meet their basic needs. Government will continue to work together with employers to assess the effects of increased minimum wages and plan for the future. **Effective October 1, 2015, the following increases to Alberta's minimum wage rates will take effect:**

- The general minimum wage will increase from \$10.20 to \$11.20 per hour
- The liquor server minimum wage will increase from \$9.20 to \$10.70 per hour
- The weekly minimum wage for certain sales people, land agents and other professionals will increase from \$406.00 to \$446.00
- The monthly minimum wage for domestic workers who live in their employer's residence will rise from \$1,937.00 to \$2,127.00
- Maximum deductions for consumed meals and accommodation provided by an employer are not changing. They will remain at \$3.35 per day for each consumed meal, and \$4.41 per day for lodging provided

Assessing & Finalizing the Tender October 15th & 16th, 2015 (Edmonton) This course for the Professional Electrical Contractor courses covers organizing the estimate, finalizing the tender, and computer aid in estimating and finalizing the tender. Since the course is aimed at Professional Electrical Contractors, very little time is spent on basic take-offs. The course addresses calculations of various overheads, mark-up theories, labor factors, evaluating risk factors, and the like, all concerns that the active business manager meets up with every day. These three parts of this course are designed to create an awareness in the Professional Electrical Contractor of the various business principles involved in preparing his or her tenders.

(COURSE FULL: Wait List in Effect) Basic Electrical Estimating (BEE) October 23rd & 24th, 2015 (Calgary)

for small contractors who are not ready to make the investment in a computerized estimating system. Designed to teach new contractors the fundamentals of preparing an electrical estimate using the Elemental Format hands-on. Arc Flash & Shock Electrical Safety Training based on CSA Z462-2015 Developed for workers that perform energized electrical work. The course curriculum is based on the 3rd edition of CSA Z462, published in 2015. The overall course content was developed using industry accepted best practice standards as the under pinning in support of meeting Provincial or Federal regulatory due diligence for arc flash and shock.

ESTS Electrical Worker training is focused on the practical application of CSA Z462 within the workplace and providing documentation tools in support of the Employer's overall Occupational Health & Safety Management System and an Electrical Safety Program. Employers are required to have an updated Electrical Safety Program that incorporates the new requirements from CSA Z462-2015 for workers to receive the most benefit from this course.

The ESTS Electrical Worker course is broken down into five sections for ease of use. Workers should self-pace themselves based on their understanding of the subject matter. All workers are encouraged to stop and start their course by saving their progress before exiting.
