NTCCC Comes to Alberta. At the request of the National Trade Contractors Coalition of Canada (NTCCC), ECAA was asked to host a meeting with executive directors from sub-trade associations within Alberta and two Ontario representatives of the NTCCC, Mr. Eryl Roberts and Mr. Tom Vivian (who are also CECA staff). Purpose of meeting was to advise and inform of the NTCCC initiatives with regards to Prompt Payment legislation drafted in Ontario. The meeting held in Edmonton was one of four that were scheduled in the Western provinces to ascertain the respective provincial industry's desire to move forward in a similar fashion in their own province and how NTCCC could be of assistance to promote, and hopefully obtain, the proper legislation required to make the construction industry more profitable to our members, and to ensure that our members have proper legislation in place to better protect their interests.

The Canadian Commission on Building and Fire Codes (CCBFC) has extended an invitation to ECAA and our members-as stakeholders in the development of the National Model Construction Codes-to take part in the fall 2011 public review of proposed changes to the 2010 National Model Construction Codes. The public review is one of the main steps in the process for developing national code documents, providing a nation-wide forum where anyone can review and comment on the changes proposed. The National Model Construction Codes, comprising the National Building, Fire and Plumbing Codes are model codes developed by the CCBFC that the provinces and territories can adopt as is, or with modifications, as part of their building, fire and plumbing regulations. The public review will run from October 24, 2011 until December 16, 2011 on the National Codes Web site, www.nationalcodes.ca. The CCBFC wishes to thank your organization and its membership for contributing to the development of Canada's National Model Construction Codes. December 8 & 9, 2011 - Assessing & Finalizing The Tender (ECAA Office, Edmonton). is

course for the Professional Electrical Contractor courses covers organizing the estimate, finalizing the tender, and computer aid in estimating and finalizing the tender. Since the course is aimed at Professional Electrical Contractors, very little time is spent on basic take-offs. The course addresses calculations of various overheads, mark-up theories, labor factors, evaluating risk factors, and the like, all concerns that the active business manager meets up with every day. These three parts of this course are designed to create an awareness in the Professional Electrical Contractor of the various business principles involved in preparing his or her tenders.
