Professional Electrical Contractor (PEC) News

SUCCESSFUL PEC breakfast session held Friday, December 2nd in Edmonton. 18 PEC's attended the first of a series of breakfast sessions around the province to provide networking opportunities for Professional Electrical Contractors and PEC student members. **Topics of discussion included when "professional" liability insurance is required and when a PEC is exempt from having to take a business license in a municipality he is working in.**

PEC Update from City of Edmonton. Business license exemption is issued to an individual who is a Professional Electrical Contractor (PEC) *or any member of ECAA who is a sole proprietor (i.e., 100% shareholder).* When enforcement contacts this individual, and they will, proof of status will be asked for. This will include a copy of a current up to date PEC membership card or proof of ECAA membership, along with a copy of Certificate of Incorporation given to each business by the Government, usually kept in a Company's manual.

Continuing Education

Registrations being accepted for all courses scheduled in 2012 (complete list on ECAA website under PEC section and in Calendar of Events):

December 8 & 9, 2011 - Assessing & Finalizing the Tender (Edmonton) This course for the Professional Electrical Contractor courses covers organizing the estimate, finalizing the tender, and computer aid in estimating and finalizing the tender. Since the course is aimed at Professional Electrical Contractors, very little time is spent on basic take-offs. The course addresses calculations of various overheads, mark-up theories, labor factors, evaluating risk factors, and the like, all concerns that the active business manager meets up with every day. These three parts of this course are designed to create an awareness in the Professional Electrical Contractor of the various business principles involved in preparing his or her tenders.

January 6 & 7, 2012 - Basic Electrical Estimating (BEE) (Carriage House Inn, Calgary) (*Waiting List Only) February 23 & 24, 2012 (Edmonton) (* Waiting List Only) For small contractors who are not ready to make the investment in a computerized estimating system. Designed to teach new contractors the fundamentals of preparing an electrical estimate using the Elemental Format hands-on. The course will address material take-off, pricing of materials, labouring of materials using the NECA Manual of Labour Units, labour costs, special overheads, general overheads and profit/contingencies.

February 9 & 10, 2012 - Legal Implications. The instructors for this course are from the legal firm of Fraser Milner Casgrain, LLP. This course will address such matter as incorporation, income tax and GST, construction contracts and subcontracts and liability thereunder, and perhaps most importantly, steps available to ensure payment, including remedies under the Builder's Lien Act. Liability in stamping and sealing drawings will also be addressed.
