**Safety Codes Council - Electrical Technical Council Update May 30, 2012.** The Electrical Technical Council held a meeting on May 14, 2012, and continued to discuss ongoing issues such as the OBIEC review, Risk Based Inspections review, New Home Warranty Program, SCO Training, and other current industry issues. **1)** The ETC discussed the **OBIEC** review and stakeholder correspondence relative to the questions and answers generated by the review. The council moved and passed a vote to recommend the OBIEC move forward with submission to the Minister for further review and public consultation. **2) The Risk Based Inspection review** is now ready for submission to the ETC council for review at the next meetings. **3)** The council discussed the **SCO training requirements** including the mandatory code cycle update training and passed the mandatory requirement for a code of ethics training. **4)** The development of the **Master Electrician Advisory Working Group** is now complete and the first meeting of this group will be held on July 3, 2012. There will be two representatives from the ECAA participating on this committee.
