FROM ACA WEBSITE:

New deal improves labour mobility for apprentices.

Alberta and Nova Scotia have signed an agreement in principle to ensure apprenticeship training is transferable between both provinces. This agreement will improve the recognition of in-province training, allow for the recognition of apprenticeship work experience hours and enhance labour mobility for apprentices in both provinces. Under this arrangement, if an apprentice takes pre-apprenticeship training at the Nova Scotia Community College (NSCC) and then moves to Alberta, their training will be recognized. This will save apprentices from writing additional exams or repeating courses. The two provinces are also working on an agreement that would make the process of moving between Nova Scotia and Alberta easier and less expensive for apprentices to continue their education. This cooperation between the two provinces will further support Nova Scotia's efforts to modernize its apprenticeship system. On July 1, the Nova Scotia government transferred the apprenticeship training division of the Department of Labour and Advanced Education to a separate agency focused on getting more employers involved, improving the number of apprenticeship opportunities in the province and helping more apprentices complete their training. The agency will work with industry to identify further opportunities for harmonization of apprenticeship training in the country. In addition to this agreement, Alberta strongly supports inter-provincial mobility of apprentices and journeymen:

- Alberta is working with other provinces and territories through the New West Partnership agreement and the Canadian Council of Directors of Apprenticeship to enhance apprenticeship mobility.
- Alberta recognizes registered apprentices and journeymen from other Canadian jurisdictions at the same level as their home jurisdiction and facilitates the transition of apprentices between provinces.
- Under the provisions of the agreement on internal trade, the Alberta Apprenticeship and Industry Training Board also recognizes the qualifications of journeymen from across Canada.

OHS Futures - Research Funding Program.

The Government of Alberta's Occupational Health and Safety Policy and Program Development Branch is excited to share with you the start of the OHS Futures: Research Funding Program. OHS Futures is a research funding program to help support a better understanding of occupational health and safety issues in Alberta's workplaces. This program will enhance the partnership between the OHS Program and experts in our province and across Canada to make better policy for the issues of today and the emerging issues of tomorrow.

The OHS Futures will distribute up to \$1 million per year for three years beginning in 2014, with a variety of OHS proposals funded.

- The program is designed to fund a range of research projects.
- The projects funded will address a variety of topics depending on OHS Program needs.

Professional Electrical Contractor (PEC) News

PEC's need 60 APD points. If you were a PEC on Jan 1, 2013 by Dec 31 2015, or in 545 days, you will need to have earned 60 Annual Professional Development (APD) points. If you became a PEC after Jan 1, 2013 you do not need to get any points for the year you received your PEC. If you became a PEC in 2013 then for Dec 31, 2015 you would need only 40 points; 20 for 2014 and 20 for 2015. If you became a PEC in 2014 then for Dec 31, 2015 you would need only 20 points for 2015.

RECORDING AND TRACKING YOUR APD POINTS

To have your APD points counted you must enter online and send a written verification to the ECAA office.

1. RECORDING APD POINTS ONLINE: To assist you to enter your APD points online or to learn which categories are available and how to count your points we have provided step by step instructions . A 7 minute video has also been produced by the ECAA office to show you how to fill out the APD online form.

How to get to the APD online form: Go to Annual Professional Development (APD) Form on the Electrical Contractors Association of Alberta website (www.ecaa.ab.ca)

1.1. Log in

1.2. Click on the PEC Annual Professional Development Form to get started, located on the lower left hand side under the grey navigator panel.

1.3. Select the year in which you are reporting your points .

Just above the year selection, you will see two lines in green that start with "click here"

One is for step by step instructions to complete the APD form and the other is the 7 minute video on how to fill out the form.

Note since this APD date entry requires your log in, ECAA office cannot enter the data for you. thy only see the points for each category and total for the year.

2. TRACKING YOUR APD POINTS

2.1 In addition to entering on line you must also submit a written confirmation of APD points to ECAA office. If the APD activity you are claiming points for issues a document (certificate or transcript of marks Training day sign off sheet, you can just photocopy this and submit). If no document available from your activity just print of the on line from your filled out to report the APD points date and sign the form and send it to ECAA office where it is put in your file. This written submission is to be done in the year you earned the points. Yes there will be spot audits and

these written records will be the paper trail that will be audited.

WHY DO WE HAVE APD POINTS:

The P of PEC stands for Professional. As a professional designation we need to demonstrate that we are staying current in our trade. It is suggested that a PEC attain 20 points per year, but must reach 60 points in three years. See the "ECAA PEC Annual Professional Development Requirements draft 3-14 " located [here](#) or request the ECAA office to email you a copy. Remember you can get up to 18 of the 20 required points by attending the annual training day and PEC AGM and ECAA AGM. Also you can earn points by attending chapter meetings.

FAQ:

What happens if I do not get my 60 APD points by Dec 31, 2015? Refer to ECAA PEC Annual Professional Development Requirements which lists the process to accommodate exceptional individual circumstances.

Project Management, September 19th & 20th, 2014 (Calgary) Increased

- investigating - the steps to follow and processes involved

Basic Electrical Estimating (BEE), October 3rd & 4th, 2014 (Calgary) For small contractors who are not ready to make the investment in a computerized estimating system. Designed to teach new contractors the fundamentals of preparing an electrical estimate using the Elemental Format hands-on. The course will address material take-off, pricing of materials, labouring of materials using the NECA Manual of Labour Units, labour costs, special overheads, general overheads and profit/contingencies.

Assessing & Finalizing the Tender, October 16th & 17th, 2014 (Edmonton) This course for the Professional Electrical Contractor courses covers organizing the estimate, finalizing the tender, and computer aid in estimating and finalizing the tender. Since the course is aimed at Professional Electrical Contractors, very little time is spent on basic take-offs. The course addresses calculations of various overheads, mark-up theories, labor factors, evaluating risk factors, and the like, all concerns that the active business manager meets up with every day. These three parts of this course are designed to create an awareness in the Professional Electrical Contractor of the various business principles involved in preparing his or her tenders.
