**Scrap metal theft** is an issue that has impacted businesses, industry and law enforcement in Alberta. The most highly valued and frequently stolen metals include **copper, aluminum, brass** and **steel**. Many of these metals are used in infrastructure development including light rail transit, electric substations and telecommunications towers. Scrap metal theft from these critical infrastructures can disrupt transportation hubs, as well as critical services such as access to 911 emergency services, hospitals and emergency operations centres. In response to these concerns, the Scrap Metal Dealers and Recyclers Identification Act was introduced. **The Ministry of Justice and Solicitor General is seeking your input on the development of the regulations for the Scrap Metal Dealers and Recyclers Identification Act.** Please visit: <https://extranet.gov.ab.ca/opinio6//s?s=24335> to complete the survey. [ACA Talks With Advanced Education Minister.](#) ACA Vice-Chair Paul Verhesen and Executive Director Ken Gibson met with Advanced Education Minister Don Scott on Monday. Once again the ACA was able to reach out to the government minister in a cordial atmosphere. As part of their discussion the pair brought up the past partnerships with the Alberta government and advocated for continued success. The ACA also reiterated its advice to the Minister as outlined in the letter sent to him last fall.

[Express Entry Changes the Focus to Quality Immigration Candidates.](#) On Jan. 1, the federal government launched Express Entry, a new immigration application management system intended to prioritize applicants and accelerate the process. Skilled workers, who want to apply to Canada's key economic immigration programs, now must create an online profile to express their interest in coming to Canada permanently. Candidates who meet the minimum criteria will be accepted into the pool and will be given a score based on language proficiency, education and work experience. According to the government, these are leading indicators of one's likelihood of integrating fully and quickly into Canada's economy and society. The highest ranking skilled workers will be invited to apply for permanent residence and can expect to see their application processed in six months or less. The first invitations to apply will be issued during the last week of January. The government of Alberta is able to use the system to select a portion of candidates for their Provincial Nominee Programs.

[New Year Means Elections on the Horizon](#) 2015 could turn into the year of the election. As the price of oil continues to fall and budgets start to tighten Premier Prentice is rumoured to be considering a spring election campaign which could come as early as March. If Alberta does have a spring election this will mean that there will be an abbreviated sitting of the legislature. Upper most on the minds of some of our members will be meeting the demands for school construction which were announced in the last year and how the province will afford them under tighter budget constraints. On the Federal scene the set election date is scheduled for October 19, 2015. In both cases the ACA will work with our partners, including local construction associations, to ensure the politicians know the concerns of our members going forward. Specific to our interest is how the changes to the immigration and education programs will fill the skills gap in our workforce. The ACA and others are working toward a common front on these items.

## Apprenticeship & Industry Training Updates

**New occupation - Overhead Door Technician** Overhead door technician has been designated as an occupation under the Apprenticeship and Industry Training Act (Act), effective January 1, 2015. Consultation with industry demonstrated strong support for the designation of overhead door technician. As members of a designated occupation under the Act, overhead door technicians may qualify for an Alberta Occupational Certificate by demonstrating the competencies described in the Overhead Door Technician Occupation Regulation. While certification is not required to work in the occupation, its availability recognizes industry-approved competencies and assessments, improving the viability of overhead door technician as a career in Alberta. An occupational designation ensures that workers have the equivalent knowledge, skills and competencies. It improves worker mobility and provides consistent standards for employers. Training and certification in the occupation increases awareness of the importance of safe working procedures and practices. **Auto Glass Technician no longer a branch of the Glazier trade** Effective January 1, 2015, the auto glass technician branch ceased to exist as a branch of the glazier trade. This means the branch is no longer regulated in Alberta. The repeal follows a period of low industry participation in the auto glass technician apprenticeship program and consultations with industry. Currently, there are only four registered apprentices in the branch. The Alberta Apprenticeship and Industry Training Board and the Glazier Provincial Apprenticeship Committee believed the branch was no longer viable in Alberta. Existing auto glass technician apprentices will not be negatively impacted by this change. Apprentices will be allowed up to two years to complete their auto glass technician apprenticeship program if they wish or be granted credit to enter into the glazier trade apprenticeship program. **Launch of Trades Competency Verification Pilot in Steamfitter-Pipefitter trade** Industry has been requesting a competency assessment tool to evaluate the practical skills of internationally-trained workers and their ability to meet Alberta industry standards. Currently there are two practices used to assess and provide evidence of competency: an employer declaration letter (EDL) or a practical assessment. **On February 4, AIT launched a pilot project for the Trades Competency Verification (TCV) in the steamfitter-pipefitter trade.** The TCV was developed to expand the options used in evaluating the practical skills of a person claiming to have the same skill set as a certified, entry-level journey person in a selected trade. The TCV is a pilot project, so it will be implemented and evaluated before continuing or expanding it to other trades. Qualification candidates must have an approved application for the Qualification Certificate - Work Experience program for the steamfitter-pipefitter trade. Once they have approval from International and Provincial Assessment Services, they will be sent a TCV book with their approval/arrival letter. The TCV book contains seven core competencies for the steamfitter-pipefitter trade. When the candidate demonstrates each competency, it must be verified by an approved assessor, who must possess an Alberta-recognized steamfitter-pipefitter journey person credential. The candidate's current employer must also endorse the quality of the assessment. Once the TCV has been verified by AIT, the candidate will be scheduled to write the qualification theory exam. The summary lists recognized trade credentials in Alberta, categorized first by the issuing jurisdiction, the Alberta trade, followed by the equivalent credential. Individuals holding a recognized trade credential are eligible to work in the full scope of the trade in Alberta based on their credential without having to sit for examinations.
