[Finding New Purpose in Older Structures](#)

The challenge of building a greener economy is how do we reuse or repurpose older buildings rather than tear them down. An article in Construction Today mentions how finding new uses for old buildings can keep historical landmarks in the present while maintaining the look of the past."Frequently, clients want to adapt old buildings with great bones instead of building new because the design elements and unique attributes within the existing structure often cannot be replicated or recreated."

Typically buildings in North America are considered dated if they are over 40 years old. The difficulty for the industry is finding a way to keep these buildings current yet maintain the look and feel. Alberta Infrastructure has expressed, in meetings with the Minister and in the Ministry business plan, a desire to maximize its inventory of older structures through reinvestment.

[Municipal Affairs Extends the NECB 2011 Mandatory Enforcement Deadline](#)

Input from municipalities, construction industry, professionals, safety codes officers and the Building Sub-Council of the Safety Codes Council has indicated that the May 1, 2016 mandatory application of the NECB 2011 will not be practical or feasible. The substantive changes required to accommodate energy efficiency with respect to design, training and verification necessitates a relatively short extension.

For that purpose an extension was announced, the new date for mandatory application will now fall November 1, 2016.

The Canadian Construction Association (CCA) recently embarked on a series of "Quality of Documents" workshops across Canada to explore and discuss the issue of poor quality documentation, its potential causes, and perhaps most importantly, potential solutions to address the issue. In total, twelve (12) workshops were held across Canada, involving more than 600 representatives from all stakeholder groups, including Owners, Architects, Engineers and Contractors.

This issue is one that has remained on the CCA radar for a number of years, and was most recently referenced during our 2014 Industry Summit as a key issue impacting our industry in the coming years. These workshops provided the opportunity to explore the causes, as well as potential solutions for the problem. The workshop structure allowed for open and candid discussions on the topic, and included an anonymous survey to rank the impact of potential causes and issues related to quality of documents.

With the workshops now complete, CCA is pleased to be publishing a summary report of both the workshops and the surveys conducted. In the report, readers will find the top five identified causes with the greatest impact on document quality, as identified from more than 400 survey results.

[Alberta Infrastructure Introduces Prompt Payment in Contracts](#)

While delayed payment is an issue across industry, Alberta Infrastructure has showed great leadership to step up and offer a solution that we hope is adopted by other owners. As part of ongoing dialogue between the Alberta Construction Association and Alberta Infrastructure, AI has changed their contracts to address the issues of prompt payment and progressive release of holdback.

Alberta Infrastructure has introduced four significant changes to their contracts.

1. The contract specifies a maximum of 30 calendar days after the initial receipt of the application for payment, provided the contractor has properly completed their claim. Infrastructure will verify the

invoice and adjust if necessary, advise the General Contractor within 14 days of the amount to be paid. Infrastructure has modified the Statutory Declaration so that the General Contractor must confirm that they paid their subcontractors within 10 days of receipt of payment from the Government.

2. Their contracts specify that amounts which are not in dispute will be paid. Disputed amounts will be resolved during the next invoice period.
3. Alberta Infrastructure has committed to publicizing the date of payment so that subcontractors and suppliers will be aware of when the prime contractor was paid (see contact info below).
4. Upon appropriate application, holdback funds will be released once the portion of the work is complete. The contractor will submit their certificate of substantial performance for their portion of the work performed, and follow normal procedures of posting the certificate at the job site. Infrastructure will verify substantial performance. After the 45 day period, the contractor then applies for release as part of the next progress claim. Warranty will still be from the date of Interim Acceptance.

Alberta Construction Association applauds these changes. Prompt pay supports jobs for Albertans and their families through increased cash flow allows companies to increase staff.

Prompt pay supports small business as it will allow companies to pursue more work with timely payments. Prompt payment saves money for taxpayers with lowers bid prices by reducing the costs of financing receivables, it will increase the number of competitive bids.

Arc Flash & Shock Electrical Safety Training based on CSA Z462-2015 Developed for workers that perform energized electrical work. The course curriculum is based on the 3rd edition of CSA Z462, published in 2015. The overall course content was developed using industry accepted best practice standards as the under pinning in support of meeting Provincial or Federal regulatory due diligence for arc flash and shock.

ESTS Electrical Worker training is focused on the practical application of CSA Z462 within the workplace and providing documentation tools in support of the Employer's overall Occupational Health & Safety Management System and an Electrical Safety Program. Employers are required to have an updated Electrical Safety Program that incorporates the new requirements from CSA Z462-2015 for workers to receive the most benefit from this course.

The ESTS Electrical Worker course is broken down into five sections for ease of use. Workers should self-pace themselves based on their understanding of the subject matter. All workers are encouraged to stop and start their course by saving their progress before exiting. At any time during the course workers can ask questions to an Instructor and follow along using a comprehensive Student Workbook as a training aid.

Students who score 80% or greater earn their training certificate and can apply for 0.6 Continuing Education Units (CEU's). Final assessment questions are fully randomized so Workers never have the same exact questions.
