#### **News from Alberta Construction Association**

#### **ACA Sends Letter of Concern Over Gypsum Decision**

ACA has sent a letter to the Canadian International Trade Tribunal expressing our concern around the increase of tariff to gypsum being imported from the USA.

Our concerns are as follows:

- 1. The cost increases may hurt our suppliers and our industry in general if they are varying dramatically across our industry.
- 2. If we have a shortage, this will create basic supply problems for the industry and schedule and cost overruns for current projects.
- 3. The cost increases would have to be passed on to the customer in succeeding contracts which may significantly impact government funded infrastructure projects.

ACA also explained that we hope that these changes will be kept from causing undo pain for our industry in a time where we are struggling to keep our businesses and employees in their jobs.

#### Significant SCC Decision Increases All Risk Insurance Coverage

The Supreme Court of Canada (the "SCC") issued a <u>decision</u> dealing with coverage under a builders' risk insurance policy that has important implications for owners, contractors and insurance companies. At issue was the interpretation of the exclusion of coverage for "the cost of making good faulty workmanship," which appears in many commercial risks policies.

Following installation of windows at a high rise commercial tower, the window cleaning company hired by the owner to remove paint from the windows scratched and damaged the surfaces by using improper tools and methods. The owner submitted a claim for the costs to replace the damaged windows. The insurance company denied coverage relying on an exclusion in the policy precluding coverage for the "costs of making good faulty workmanship". There was an exception to this exclusion that the owner relied upon. This exception provided that coverage would still be available for physical damage resulting from the faulty workmanship.

# Government Sends Notice Regarding Mandatory Compliance with NECB 2011

The Alberta government sent the following <u>notice</u> as a reminder that the transition period for voluntary application of the National Energy Code for Buildings (NECB) 2011 and Section 9.36. Alberta Building Code (ABC) 2014 for housing and small buildings ends on November 1, 2016.

Where an application for a building permit for a site-constructed building is received on or after November 1, 2016, the building design must comply with the requirements of the NECB 2011 or Section 9.36. ABC 2014 as appropriate. Please see the April 2016 Interpretation STANDATA - Application of Energy Efficiency Requirements and Enforcement Dates for details on application of the NECB 2011 and Section 9.36 ABC.

Energy codes are an important component of climate change strategies in Alberta, Canada and globally.

For this reason, owners, builders and designers are encouraged to voluntarily apply energy efficiency requirements during this transition period. Alberta and other provinces and territories are committed to the expeditious adoption of future editions of the national energy codes and improved energy efficiency standards.

Alberta Government Announces New Small Business Tax Credit

A tax credit for investments in small Alberta businesses would support up to 4,400 new jobs over three years and contribute up to \$500 million to the province's GDP.

As part of the Alberta Jobs Plan, legislation to create the Alberta Investor Tax Credit (AITC) will be introduced during the fall sitting of the legislature. It will offer a 30 per cent tax credit for investments in Alberta small business made between April 14 of this year and December 31, 2019. The AITC would have a budget of \$90 million over three years and would be provided on a first-come, first-served basis.

The tax credit would be available for investments in companies that are substantially engaged in proprietary technology research, development or commercialization; interactive digital media development; video post-production; digital animation; or tourism.

The investment criteria were developed through extensive consultation with business and investment leaders across Alberta and are designed to encourage economic diversification. The registration process for the tax credit will be announced pending the passage of accompanying legislation this fall.

# ACA Letter to the Task Force on Marijuana Legalization and Regulation

On September 21st, ACA sent a letter from our Chair Paul Verhesen expressing concerns regarding the legalization of recreational use of marijuana in 2017. ACA recommended the following be in place prior to legalization:

- Legislation should be enacted to:
- Confirm that, provided appropriate scientific, medical, assessment, rehabilitation, protection of privacy, and investigative programs are in place, the employer's responsibility to ensure workplace safety trumps the rights of workplace personnel. Provided that the employer has appropriate site access, random testing, postincident investigation policies in place, and followed appropriate procedures, protect employers from human rights complaints or litigation arising from implementing these policies and procedures.
- prohibit the possession and use of marijuana on or near

construction sites

- prohibit the possession and use on or near construction sites of any substance or device intended to tamper or effect testing of marijuana use or impairment
- Tools are available to employers to assess impairment and that until research provides clear cut thresholds or other measures of impairment, an employer's reasonable presumption of impairment prevails
- Tools are in place to determine when addiction is effectively treated, such that individuals can be reemployed at construction sites. Until research provides clear cut measures to determine effective treatment, an employer has the right to refuse reemployment

Employers are working on lean business practices and are relying on top performance from all members of an organization. Punctuality, dedication, work ethic, heart and what I like to call a little grit. If you come to work on time, have the dedication to your apprenticeship, work hard and efficiently, have pride and enthusiasm in completing tasks and projects and last but not least.... grit.... When the job gets tough, when your supervisor hands you a shovel, when the rain just won't quit, when the cold seems too much, when the cable pull seems like you could have ten more guys..... push through. Find the strength to keep moving forward and know in your heart and mind that you can complete this task and any other task, no matter the circumstances.

With all of that there is the 2nd part to your apprenticeship contract, the employer. It may be your boss, it may be your supervisor on a project or maybe it is your direct journeyman on a service call. Their part of the contract is to train you. A Board meeting was held on Thursday, September 15th at the ECAA Boardroom in Edmonton. Mr. Gord Sheppard began the Board meeting with his workshop on How to Create Awesome Meetings. Joining the above for the 10:15 am Board meeting were Mr. Bob Clarke; Mr. Larry Cantelo, PEC; Mrs. Jeanette DeBruin; Mr. Chris Rauschning, PEC; and Mr. Hans Tiedemann. Correspondence included a letter from Alberta Construction Association to Premier Notley. Mr. Milot reported that Alberta Infrastructure

has taken a strong lead on how they pay their contractors. This is proceeding well. A thank you letter from Mr. Lafrance who was a recipient of an ECAA Skills Competitions honorarium. Thank you letter received from code instructors for invitation to Training Day, Awards luncheon and Gala. Thank you letter received from Minister Larivee regarding ECAA extending screening services to aid in Fort McMurray fire relief efforts.

Business Arising included discussion on the amended ByLaws to include Retired membership categories. Re-filing the amended ByLaws was initially rejected as ECAA does not have provision for removal of a Director. Following discussion, ByLaw was subsequently approved with assurance that ECAA will address removal of a director through a Special Resolution at our 2017 Annual General Meeting. Request made to Past Presidents to draft this Special Resolution working under Article 7 of the ByLaws. Additional information was requested by Trademark Examiner regarding filing the 50th anniversary logo as an official mark. Retired membership application was approved and a fee approved of \$50 per year for each of the retired membership categories.

60/90 Overdue accounts were reviewed; July Pro Forma and Wood Gundy investments discussed; and 2017 Budget requests handed out to Board.

PEC Committees were approved. Mr. Bob Clarke reached out to each Chapter President to appoint a volunteer from the Associate members in their Chapter for better Provincial representation to the Associate Liaison Chair. Mr. Cantelo, PEC reported that PEC Education Committee currently looking at three courses: Blueprint Reading, Grounding & Bonding and Hazardous Locations.
