

Fuzzy Risk Analyzer for Construction Project Risk Analysis is a database-driven software tool for assessing project risks and opportunities and calculating contingency. It allows users to express the probability and impact of risk or opportunity events using their own language. This approach to risk analysis does not require historical data yet it provides results similar to Monte Carlo simulation-based risk analysis.

Agenda items included approval of agenda and October 19th minutes. Update provided on the 40-hour fire alarm course that will be offered by ECAA for out-of-Alberta journeyperson electricians to enable them to receive their PIN number (also a refresher course for industry). Alberta starting the first student Chapter of CECA in Western Canada which will be set up at the University of Alberta. The chapter is recognized by NECA, who

will make their courses available to the students. ECAA was asked to forward a request to members to send in comments to Minister Bill Moreau expressing support for prompt payment legislation on federal construction projects. All Chapter and Committee reports were included in the recent Contactor. Presentation to Board by Terry Becker on importance of employers and employees being aware of arc flash and shock requirements. One day low voltage course scheduled in each of the Chapters.

Z462 and Z463 now a National standard in Canada. 2018 Edition of IEEE 1584 Guide for Performing Arc-Flash Hazard Calculations recently published. "The new edition is based on more than 2000 tests spanning a wide range of voltages, configurations and parameters, and features more detailed model and new equations.

One of the major changes is introduction of new electrode / bus configuration. The 2002 edition was based on arc flash tests with electrodes in a vertical orientation. To provide greater modeling flexibility for equipment, five different electrode/bus configurations have been included in the testing program and subsequent model development which include:

- VCB Vertical electrodes in a metal box/enclosure
- VCCB Vertical electrodes terminated in an insulating barrier in a metal box
- HCB Horizontal electrodes in a metal box
- VOA Vertical electrodes in open air
- HOA Horizontal electrodes in open air

The IEEE 1584-2018 model features a more accurate arcing current variation based on the electrode configuration as well as other factors. The variations that occur in the actual arcing current may have a major impact on circuit protection device operating time, arc duration and calculated incident energy. Also, an enclosure size correction factor has been introduced to address the impact of enclosure size on the arc flash energy being expelled and reaching a worker."

New Course On Seismic Design Being Offered

The Canadian Society for Civil Engineering is offering a course on performance-based seismic design of tall reinforced concrete buildings as part of a continuing education course.

This course covers detailed information from the conception to the final design of a Reinforced Concrete Shear Wall building using a performance-based seismic design (PBSD)approach. It includes hands-on experience in the application of PBSD on several building projects on the West Coast of USA. It goes over the concept of PBSD, its development and key aspects of the general approach. It also presents an overview of the latest PBSD guidelines currently used and a brief review of current code requirements and how they differ from the PBSD approach.

The instructor is Freddy Pina,Ph.D., P.Eng., President of PBRV Consulting Ltd., a company that offers professional services to structural engineering firms with the main focus being in the seismic design of tall buildings using a performance-based design approach and in the assessment of the potential risk of failure or damage of existing buildings. Dr. Pina has been involved in the seismic design of numerous tall buildings as well as in the seismic risk assessment of several existing buildings. He is also an Adjunct Professor at the University of British Columbia.
